A. Personal Statement

I has been engaged in institutional research for about 17 years, both in theoretical and practical fields. The matters of formal and informal institutions quality assessment are particularly complicated. In Russia and other federal countries institutions should be studied with consideration of their regional specific features.

The basis of wealth is population incomes. In order to assess differentiation of population money incomes the authorial method for accounting of ruble purchasing power parity in regions of Russia is applied. This method allowed to improve the analysis level of large information massives in social statistics.

In the university I teach Institutional economics and Methodology of economic science, supervise scientific and research work of students and post-graduates. Also I am a head of the scholar school named "Novosibirsk school of institutional economics and economic policy".
