

## 38.03.01 BACHELOR PROGRAMME IN ECONOMICS

### OVERVIEW

**Course:** Accountancy, analysis, audit

**Degree:** Bachelor **Course Duration:** 4 years

**Description.** The graduates of the programme are prepared for economic estimation, analytical and managerial activities in the field of accountancy, economic analysis, audit, and also international standards of financial statements. The graduates of the programme are able to estimate economic and social-economic indicators of an organization's activities on the basis of standard methods and current regulatory-legal framework; to analyze and interpret financial, accounting and other types of information, which is presented in financial reporting of enterprises of different legal forms, organizations, government agencies, and to use the obtained information to make managerial decisions. There is traditionally high demand for the graduates of the educational programme: the specialists in the above-mentioned professional spheres are in great demand in organizations of all organizational-legal forms and types of economic activity. This allows the graduates to find a job in accordance with their qualification.

**Programme Department.** The programme department is Accountancy and Statistics Department. In addition to education activity in the framework of bachelor and master training (Higher Professional Education) and also research work, the teaching staff of the department prepares professional accountants and financial managers in accordance with the educational programmes of the Institute of Professional Accountants and Auditors of Russia in the acting certified training centre of the department.

**Teaching Staff.** The core teaching staff of the graduate programme department consists of 12 people, including two Doctors of Economics, one professor and eight Candidates of Economic Sciences; five certified qualified accountants and one IFRS (International Financial Reporting Standards) certified specialist. The teaching staff take professional development courses in the disciplines they are responsible for, and advanced teaching technologies courses on a regular basis. Besides, leading specialists from other universities and organizations of Novosibirsk are invited to work in a part-time position and to review graduation theses.

**Work-Based Training.** From the 2d year students have teaching practice, job training, research practice and do internships in industrial enterprises, government structures of different levels, consulting and auditing firms, banks, investment and insurance companies, including the Ministry of Finance and Tax Policy in Novosibirsk region, the Interregional Directorate of Federal Service of Alcohol Market Regulation in Siberian Federal District, in auditing firms "TriO-Audit" (Novosibirsk), "Audit-Standart" (Krasnoyarsk), Novosibirsk manufacturing group "Sibsel'mash", etc.

**Employment.** The graduates of the educational programme are qualified to work in industrial enterprises, trade organizations, commercial banks, service industry organizations, auditing and consulting organizations.

**Future Careers:** accountant, analyst, auditor, economist, financial reporting specialist, management accounting specialist, financial manager, cost accountant, planning economist, budget analyst, tax and dues department accountant, tax specialist, etc.
