Course: <u>Economics of Enterprises and Organizations</u>

Degree: <u>Bachelor</u> Course Duration <u>– 4 years</u>

**Description:** The course "Economics of Enterprises and Organizations" is aimed at preparing holders of Bachelor's degree in Economics with in-depth knowledge in economics of real sector organizations. This education provides students with combination of extensive expertise in economics and management of knowledge-intensive industries. This makes graduates unique specialists, who are always in great demand in the labour market.

**Core Economic Subjects:** History of economics, Microeconomics, Macroeconomics, Accountancy and analysis, Marketing, Industrial markets theory, Institutional economics, Money, credit, banks, Corporate finances, Economics of an enterprise (organization), Tax and taxation policy, World economics and international economic relations, Economic analysis theory, Basics of innovation economics, etc.
